Information We Collect:

Information You Provide:

When you register for an account, we collect Personal Information such as your name, email address, and other information you provide.

A few of our features also use and display the meeting titles in your calendar. When using our Google Calendar integration, we collect authentication information to connect to your Google account and access calendar data for scheduling purposes. You can remove/disable it whenever you want.

Google Information: We don't share your Google data with any other third-party services as of now.

OpenSphere's use and transfer of information received from Google APIs to any other app will adhere to <u>Google API Services User Data Policy</u>, including the Limited Use requirements.

Information from Third Parties:

If you choose to connect your account with a third-party service, we may receive or be granted access to information from such third-party service, including Personal Information. For example, if you use Google for calendar integration, we can check the calendar to check for available times for scheduling. You can stop sharing your information from a third-party service

with us by removing our access to that service. OpenSphere processes that information on the User's behalf as a processor or service provider.

Automatically Collected Information:

When you use our Services, we automatically collect information such as your IP address, browser type, operating system, and other usage information about the use of our Services, including a history of the pages you view.
